A half year membership is \$30.00, and starts in July for new members only. Name tags (not included in membership dues) are \$6.00 each and are recommended. Members not paid by March 31st will be removed the Clubs Membership listing. The Corvette Club meeting is on the third Thursday of each month, at the Lakewood Rod & Gun Club at 433 East Terrace Avenue in Lakewood, NY, at 7:00 pm. Check the club website for more information regarding the club meeting times and places. NOTE: Sometimes meeting places change during the year due to a special Club Event. Also, there are no club meetings for January and February each year and we have special functions on various other months so watch the calendar and web site for these events.

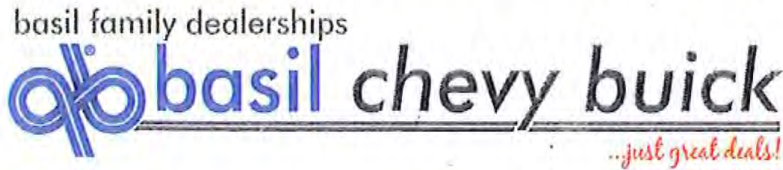
