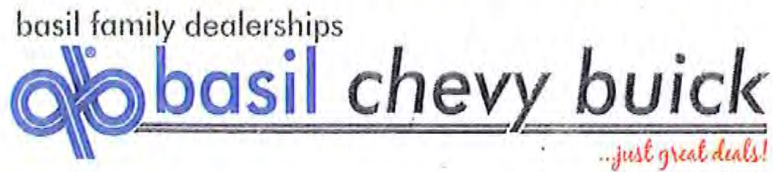



A half year membership is \$30.00, and starts in July for NEW members only. Name tags (not included in membership dues) are \$6.00 each and are recommended. Members not paid by March 31<sup>st</sup> will be removed from the Club's Membership listing.
