## Message from the President

APRIL2019

Spring is just around the corner and it is time to start planning to get our cars out of storage, if you have not already done so. Vic Anderson is looking into a cruise-in at a local ski area (**Cockaigne**) and will discuss this at the April meeting. The date for this cruise-in is **Father's Day, Sunday June 16<sup>th</sup>.** I am, also, looking for someone to present a topic of interest that they have to our club membership at one of our meetings. If anyone would like to share one of their areas of interest, please let me know so we can plan this presentation at one of our meetings. It does not have to be related to corvettes.

**Thursday April 18<sup>th</sup> will be our first official club meeting for 2019**. This is a change from the original date of April 11<sup>th</sup> so be sure to correct your calendar. One of the topics to be discussed at the April 18<sup>th</sup> meeting will be changes to the By-Laws as it relates to voting on club Officers/Directors and major changes in the club, should they be needed. The BOD has approved the changes and we need to review these with the members attending this April meeting and then have them permanently added to the club By-Laws.

We are getting some interest from other corvette clubs to either have us take part in their functions or have them take part in our events. I will have more on this topic at the meeting on the 18<sup>th</sup>. The **Quaker Steak & Lube trip to Sharon, Pa is set for Sunday April 28<sup>th</sup>** and additional information will be sent out in the coming weeks. 

A half year membership is \$30.00, and starts in July for new members only. Name tags (not included in membership dues) are \$5.50 each and are recommended.
